### QUADE, WILLIAM C., Vol. 2, p. 328

3/28/1918 Appointed Private 1<sup>st</sup> Class, vice J.P. Breckinridge resigned.  
10/26/1918 Tried. Violation par. 17, ec. 11 (Conduct prejudicial to reputation, good order, and discipline of the force).  
1/3/1919 Removed after this date.

### QUAIL, HARRY A., Vol. 1, p. 295

6/11/1898 Appointed Private 1<sup>st</sup> Class  
7/1/1901 Promoted to Bicycle Officer, original vacancy.  
11/9/1901 Tried. Conduct unbecoming an officer. Guilty. Cautioned.  
6/10/1903 Tried. Conduct unbecoming an officer and neglect of duty. Guilty. Be dismounted from bicycle, transferred and warned.  
9/25/1903 Dismounted from bicycle.  
1/12/1904 Tried. Neglect of duty. Guilty. Fined \$5.00 and warned against repetition.  
2/5/1904 Charged with neglect of duty and conduct unbecoming an officer. Guilty. Fined \$5.00, transferred and warned against repetition.  
9/27/1904 Charged with neglect of duty. Guilty. Be deprived of two days' leave and warned against any violation of orders or regulations in future.  
10/29/1904 Tried. Violation of par. 157 & 160 of manual. Guilty. Fined \$50.00.  
6/23/1906 Honorably discharged.  
6/24/1906 Pensioned at \$5.00 per month.  
7/1/1906 Pension increased to \$50 per month for six months from this date.  
1/1/1907 Pension increased permanently from \$5 to \$40 per month.  
8/1/1908 Pension discontinued for failure to submit to 2-year examination, see CO 251,232.  
8/1/1908 Above order rescinded.  
1/27/1910 Died.

9/25/1894 Appointed Private 1<sup>st</sup> Class.  
7/21/1895 Tried. Absence from duty without leave. Fined \$5.00.  
9/25/1895 Tried. Conduct unbecoming an officer. Not Guilty. Charges dismissed.  
11/27/1895 Tried. Conduct unbecoming an officer. Not Guilty. Charges dismissed.  
4/2/1896 Tried. Gross neglect of duty. Charges dismissed.  
12/11/1898 Tried. Gross neglect of duty. Charges dismissed.  
3/17/1900 Tried. Gross neglect of duty. Guilty 3<sup>rd</sup> specification. Cautioned.

5/23/1900 Tried. Neglect of duty. Guilty. Be removed from force.  
6/20/1900 Permitted by Hon. Commissioners to resign.

QUILL, LAWRENCE J., Vol. 1, p. 294

7/1/1897 Appointed.  
3/18/1899 Tried. Neglect of duty. Charges dismissed.  
7/1/1906 Promoted to Private 3<sup>rd</sup> Class, original vacancy.  
1/25/1909 Tried. Neglect of duty. Guilty. Warned to be more careful.  
8/8/1913 Tried. Violation par. 1, sec. 11 (conduct prejudicial to good order, etc.) Charges dismissed but warned against altercation with citizens while in pursuit of official duty.  
12/31/1915 Honorably discharged.  
1/1/1916 Pensioned at \$50.00 per month.  
6/23/1916 Died.

QUINLAN, M.W., Vol. 1, p. 293

11/6/1873 Appointed  
12/12/1879 Tried. Conduct unbecoming a policeman. Charges dismissed.  
12/9/1884 Made Hack Inspector.  
7/1/1891 Promoted to Detective.  
7/15/1897 Reduced to Private 1<sup>st</sup> Class account of physical disability.  
5/3/1899 Died.

QUINLAN, THOMAS F., Vol. 2, p. 328

8/5/1906 Appointed Private 1<sup>st</sup> Class, vice L.W. Giles promoted.  
8/5/1909 Promoted to Private 2<sup>nd</sup> Class, original vacancy.  
8/5/1914 Promoted to Private 3<sup>rd</sup> Class original vacancy.  
9/30/1922 Relieved as Private 3<sup>rd</sup> Class after this date.  
10/1/1922 Transferred to White House Police Force this day.

8/21/1894 Appointed Private 1<sup>st</sup> Class.  
5/27/1896 Tried. Neglect of duty. Guilty. Fined \$5.00.  
8/26/1896 Tried. Conduct unbecoming an officer. Charges dismissed.  
3/24/1900 Tried. Neglect of duty. Charges dismissed.  
6/23/1900 Charged. Violation of par. 157 of the manual. Fined \$5.00  
3/24/1902 Tried. Conduct unbecoming an officer. Fined \$10.00 and warned.  
11/26/1902 Tried. Nonpayment of debt. Guilty. Be required to pay.  
12/6/1902 Tried. Absence without leave. Guilty. Be fined \$10.00.

1/16/1903 Charged. Conduct unbecoming an officer and absence without leave. No action, see below.  
1/21/1903 Permitted to resign.
